AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO REZONING 6.740 ACRES LOCATED IN SOUTHEASTERN SAN DIEGO AND ENCANTO NEIGHBORHOODS, WITHIN THE SOUTHEASTERN SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE SOUTHEASTERN SAN DIEGO PLANNED DISTRICT AND THE MOUNT HOPE PLANNING DISTRICT ORDINANCE TO THE RS-1-1, RS-1-2, RS-1-4, RS-1-6. RS-1-7, RX-1-1, RM-1-1, RM-1-2, RM-2-5, RM-3-7, CN-1-3, CN-1-4, CC-3-4, CC-3-6, CC-2-1, CO-2-1, IL-3-1, OP-1-1, AND OC ZONES, AND REPEALING ORDINANCE NOS.O-19599 AND O-19593, ADOPTED MARCH 27, 2007, OF ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That 6,740 acres located in Southeastern San Diego and Encanto Neighborhoods, and legally described as in the appended boundary description file in the office of the City Clerk under Document No. OO
20580

, within the Southeastern San Diego Community Plan area and Encanto Neighborhoods Community Plan area, in the City of San Diego, California, as shown on Zone Map Drawing No. C-959 and No. C-960, filed in the office of the City Clerk, are rezoned from the Southeastern San Diego Planned District and the Mount Hope Planned District into the Land Development Code zones including RS-1-1, RS-1-2, RS-1-4, RS-1-6, RS-1-7, RX 1-1, RM-1-1, RM-1-2, RM-2-5, RM-3-7, CN-1-3, CN-1-4, CC-3-4, CC-3-6, CC-2-1, CO-2-1, IL-3-1, OP-1-1, and OC, as the zones are described and defined by San Diego

(O-2016-31)

Municipal Code Chapter 13, Article 1, Divisions 2, 4, 5, and 6. This action amends the

Official Zoning Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance Nos. O-19593 and O-19599, adopted March 27, 2007,

of the ordinances of the City of San Diego are repealed insofar as the same conflict with

the rezoned uses of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to its final

passage, a written or printed copy having been available to the City Council and the

public a day prior to its final passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day

from and after its passage, and no building permits for development inconsistent with the

provisions of this ordinance shall be issued unless application therefore was made prior to

the date of adoption of this ordinance.
