A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE PROPOSED BYLAW
AMENDMENTS FOR THE KENSINGTON-TALMADGE
PLANNING GROUP.

WHEREAS, the Kensington-Talmadge Planning Group recently submitted proposed
bylaw amendments to the City that conflict with Council Policy 600-24; and

WHEREAS, the Planning Department and the City Attorney's Office have reviewed the
proposed bylaw amendments and determined Kensington-Talmadge Planning Group's proposed
bylaw amendments contain one deviation from the bylaws shell; and

WHEREAS, Council Policy 600-24 titled "Standard Operating Procedures and
Responsibilities of Recognized Community Planning Groups," was revised and approved by the
City Council in 2007 with Resolution No. R-302671; and

WHEREAS, approval of the Council Policy 600-24 specifies that bylaws will be
reviewed and approved by the offices of the Mayor and City Attorney unless there are
inconsistencies with the Council Policy; and

WHEREAS, in such cases, the bylaws will be forwarded to the City Council President
who shall docket the matter for Council consideration; and

WHEREAS, the proposed deviation relates to the composition of subcommittee
members; and


WHEREAS, the Kensington-Talmadge Planning Group's proposal would allow the
establishment of at least one Maintenance Assessment District Subcommittee with a majority of
members who are not Planning Group members; and

WHEREAS, Council Policy 600-24 requires that “subcommittees shall contain a majority of members who are members of the planning group,” (Article VI Section 2(b)(3)); and

WHEREAS, the Maintenance Assessment District Subcommittee(s) would consist of a minimum of three, but no more than seven members appointed annually by the Chairperson of the Kensington-Talmadge Planning Group and would be subject to the confirmation of the elected planning group members; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that it approves the proposed bylaw amendments for the Kensington-Talmadge Planning Group.
