A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXPENDITURES RELATED TO SETTLEMENT AGREEMENTS WITH NATIONAL STEEL AND SHIPBUILDING COMPANY AND WITH BAE SYSTEMS IN UNITED STATES DISTRICT COURT CASE NO 09-CV-02275-AJB (BGS)

WHEREAS, the San Diego Regional Water Quality Control Board Cleanup and Abatement Order No. R9-2-12-0024 (Order) requires cleanup of polluted sediments in San Diego Bay near the shipyards now operated by National Steel and Shipbuilding Company (NASSCO) and BAE Systems; and

WHEREAS, the Order names the City of San Diego as one of several responsible parties; and

WHEREAS, the City has been in litigation with other responsible parties over the costs of the cleanup in United States District Court Case No. 09-CV-02275-AJB(BGS); and

WHEREAS, after due public notice the San Diego City Council discussed the litigation in its closed session of December 16, 2014, at which time the City Council authorized settlements with NASSCO and BAE Systems; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that

1. The Mayor or his designee is hereby authorized to execute settlement agreements with NASSCO and with BAE Systems in United States District Court Case No. 09-CV-02275-AJB (BGS).

- 2. All reservations on payments made or to be made to the San Diego Bay

  Environmental Restoration Trust South (South Trust) from the \$6 million appropriation made

  by San Diego Resolution R-308451 (October 8, 2013) for the remediation of the NASSCO

  shipyard sediments are hereby released, and future payments required under the NASSCO

  settlement are hereby authorized to be paid from that same prior appropriation.
- 3. The Chief Financial Officer or his designee are hereby authorized to pay NASSCO by check the sum of \$1,070,204 from the remainder of the \$6 million prior appropriation made by Resolution R-308451, at a time required by the terms of the settlement with NASSCO.
- 4. All reservations on payments made or to be made to the San Diego Bay Environmental Restoration Trust North (North Trust) from the \$9 million appropriation made by San Diego Resolution R-309143 (July 28, 2014) for the remediation of the BAE Systems shippard sediments are hereby released, and future payments required under the BAE Systems settlement are hereby authorized to be paid from that same prior appropriation.
- 5. The Chief Financial Officer or his designee are hereby authorized to pay BAE Systems by check the sum of \$792,880 from the remainder of the \$9 million prior appropriation made by Resolution R-309143, at a time required by the terms of the settlement with BAE Systems.
- 6. The Mayor or his designee are hereby authorized to reallocate prior appropriations made by R-308451 and R-309143 between the South Site and North Site as necessary to meet the requirements of the settlements and to maintain compliance with San Diego Regional Water Quality Control Board Order No. R9-2012-0024.
