DATE OF FINAL PASSAGE JAN 20 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ACCEPTANCE OF GRANT FUNDING FROM THE COUNTY OF SAN DIEGO, EXPENDITURE OF THAT GRANT FUNDING, AND APPROVAL OF A CONTRACT WITH RADY CHILDREN'S HOSPITAL – SAN DIEGO TO IMPLEMENT THE SAFE ROUTES TO SCHOOL INTERGENERATIONAL PROGRAM FOR MIDDLE SCHOOLS IN SOUTHEASTERN SAN DIEGO.

WHEREAS, the County of San Diego Health and Human Services Department has developed a new program called the Safe Routes to School (SR2S) Intergenerational Program; and

WHEREAS, the SR2S Intergenerational Program will provide funding to connect older adults and students in an effort to increase their physical activity and improve their health, and provide a safer environment for children to walk and ride bicycles to school; and

WHEREAS, the City would be awarded \$90,000 in SR2S Intergenerational Program grant funding to implement this project in Southeastern San Diego; and

WHEREAS, the City would enter into a contract with Rady Children's Hospital – San Diego (Rady Children's Hospital) to implement the grant program; and


WHEREAS, Rady Children's Hospital is a non-profit entity and is engaged in administering SR2S projects within the City of San Diego; and

WHEREAS, the project would provide increased public health and safety awareness through the implementation of the SR2S Intergenerational Program that would be administered by Rady Children's Hospital; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Chief Financial Officer is authorized to accept, appropriate, and expend an amount not to exceed \$90,000 from Grant No.1000439-2015 from the County of San Diego if the grant funding is secured and upon receipt of a fully executed grant agreement.
2. That the Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.
3. That the Mayor or his representative is authorized to execute, sign, and enter into a contract with Rady Children's Hospital - San Diego to provide services in order to implement the Safe Routes to School Intergenerational Program in an amount not to exceed \$90,000 from Grant No. 1000439-2015 from the County of San Diego.


