A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO CONFIRMING AN APPOINTMENT
TO THE PARKING ADVISORY BOARD

WHEREAS, the Parking Advisory Board (the Board) is established in the San Diego Municipal Code under Chapter 2, Article 6, Division 18 to advise the Mayor and City Council on policy issues relating to parking; and

WHEREAS, the Municipal Code provides that the Board shall consist of seventeen members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Municipal Code provides that the members shall serve staggered two-year terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of December 31; and


WHEREAS, the Municipal Code provides that of the seventeen members, the Mayor shall appoint: (1) eight members, one each from a list of two nominations submitted by each Councilmember; (2) one at-large member; (3) one member from each of the six Community Parking Districts; (4) one member from the Community Planning Committee; and (5) one member from the Business Improvement District Council;

WHEREAS, the Mayor now seeks confirmation of an appointment to the Board seat representing the Pacific Beach Community Parking District; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment by the Mayor of the City of San Diego, to serve as a member of the Parking Advisory Board, for the term expiring as indicated, is made and hereby confirmed:
