DATE OF FINAL PASSAGE MAR 11 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO ENTER INTO JOINT USE AGREEMENTS
WITH SAN DIEGO GAS AND ELECTRIC FOR
UNDERGROUNDING OVERHEAD POWER TRANSMISSION
LINES ALONG BALBOA AVENUE AND EASTGATE MALL
PROJECT AREAS.

WHEREAS, the Utilities Undergrounding Program is planning to underground the overhead power transmission lines associated with the Balboa Avenue Transmission project, which would cover approximately 10,445 feet of overhead transmission lines on Balboa Avenue between Santa Fe Street and Mount Everest Boulevard; and

WHEREAS, San Diego Gas & Electric (SDG&E) proposed to adjust the alignment of the Balboa Avenue Transmission project to include Clairemont Drive north of Balboa Avenue and connect at Lakehurst Avenue, which will allow SDG&E to remove a total of 30,320 linear feet of transmission overhead lines;

WHEREAS, because SDG&E will lose certain easement rights when transmission lines are undergrounded in the public right-of-way, SDG&E has requested a Joint Use Agreement under which the City would be responsible for up to 50% of any future costs if the City should require SDG&E to relocate their lines;


WHEREAS, for the Eastgate Mall Project, SDG&E currently has easement rights for their equipment that will be lost when this equipment is relocated underground; and

WHEREAS, SDG&E has requested a Joint Use Agreement for an area of 30 feet by 15 feet within the Eastgate Mall Project alignment where the City would be responsible for up to

50% of any future costs if the City should require SDG&E to relocate their lines; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his
designee is authorized to enter into Joint Use Agreements with SDG&E for the Balboa
Transmission Project and the Eastgate Mall Project for the purpose of undergrounding overhead
power transmission lines.


