A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO APPROVE THE WATER SUPPLY ASSESSMENT FOR THE BALLPARK VILLAGE PARCEL C RESIDENCE PROJECT

WHEREAS, on January 1, 2002, Senate Bill 610 (SB 610) and Senate Bill 221 (SB 221) took effect, and are now part of California Water Code section 10910-10915, which requires the preparation of a water supply assessment (WSA) for inclusion in the environmental documentation of projects that would demand an amount of water equivalent or greater than the amount of water required by a 500 dwelling units project, and is subject to the California Environmental Quality Act (CEQA); and

WHEREAS, Civic San Diego, formerly Centre City Development Corporation, requested that the City of San Diego (City) Public Utilities Department (Department) prepare this WSA as part of the environmental review for the Ballpark Village Parcel C Residences Project (Project); and

WHEREAS, Department staff, in accordance with state law, conducted the analysis using the City of San Diego 2010 Urban Water Management Plan and San Diego County Water Authority 2010 Urban Water Management Plan (CWA 2010 UWMP), which are based on SANDAG Series 12: 2050 Regional Growth Forecast; and

WHEREAS, the future water demands of the Project will be accounted for through the Accelerated Forecasted Growth Demand increment of the CWA 2010 UWMP; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the WSA for the Ballpark Village Parcel C Residences Project is hereby approved.
