DATE OF FINAL PASSAGE. MAR 1 1 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING A SURPLUS IN THE DEL MAR TERRACE UNDERGROUND UTILITY ASSESSMENT DISTRICT.

WHEREAS, in 1998 and prior to the implementation of the Utilities Undergrounding Surcharge Fund, property owners within the Del Mar Terrace neighborhood expressed interest in forming a Special Assessment District under the Municipal Improvement Act of 1913, for the purpose of undergrounding overhead utilities within their community; and

WHEREAS, the petition to initiate the process to form an Assessment District was approved by the City Council on March 29, 1999 (Resolution 291436). The results of the Assessment Ballot were approved by the City Council during the Public Hearing held on June 1, 1999 (Resolution 291731). The City Council approved the assessment of \$1,162,200.00 from 150 parcels in the Del Mar Terrace community for the purpose of undergrounding the overhead utilities; and

WHEREAS, the total project budget was \$1,162,200.00, but \$1,162,530.03 was collected, and total expenditures were \$1,011,512.28, resulting in a surplus of \$150,687.72. The planned refund includes the surplus and \$204,390.30 of earned interest, for a total of \$355,078.02; and

WHEREAS, upon approval by the City Council, the Office of the Comptroller will issue a refund to the current property owners of record, with each property owner receiving a refund amount in the same proportion in which the assessment was originally levied, as determined in the Engineer's Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, to declare surplus funds in the Del Mar Terrace Underground Utility Assessment District, Fund 200501, Del Mar Terrace, in the amount of \$355,078.02, as outlined within the State of California – Street and Highways Code § 10427, which was originally established to fund the project for the purpose of undergrounding overhead utilities within the Torrey Pines Community Planning Area.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to reduce the Capital Improvement Program budget by de-appropriating \$150,687.72 in Fund 200501, Del Mar Terraces, AID00001, Undergrounding of City Utilities.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$355,078.02 from Fund 200501, Del Mar Terrace, Internal Order 12004117, for the purpose of returning excess budget to property owners of record.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to close Fund 200501, Del Mar Terrace.
