A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO SAN DIEGO SECOND CHANCE PROGRAM FOR JOB READINESS TRAINING, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, Council Policy 100-06, "City Council Funding of Community Projects,
Programs and Services" (CPPS), provides a procedure and uniform requirements for awarding
funds to and contracting with non-profit organizations and public agencies for one-time
community, social, environmental, cultural or recreational needs which serve a lawful public
purpose; and

WHEREAS, San Diego Second Chance Program ("Second Chance") has requested funding for its Job Readiness Training program; and

WHEREAS, the requested funding will be used to defray the cost of the four-person staff supporting the Second Chance Job Readiness Training Program; and

WHEREAS, Second Chance's Job Readiness Training Program consists of a four-week, 160-hour curriculum during which participants acquire critical job skills, helping them find and retain employment, with classes focusing on attitudinal changes, professional disciplines, computer literacy, financial literacy, and job placement; and

WHEREAS, the ultimate goal for the training program is to build toward economic empowerment for each client by creating access for them to become self-sufficient through a combination of soft skills (interviewing techniques, team-building, etiquette) and hard skills (resume composition, computer and financial literacy, public speaking); and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, "Community Projects, Programs and Services;" and

WHEREAS, Council Districts 5 and 7 recommend an allocation not to exceed \$10,000 to Second Chance for the purposes set forth herein attributed as follows: Council District 5 - \$5,000; and Council District 7 - \$5,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06, 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement with Second Chance in an amount not to exceed \$10,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-309512

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,000 from the Community Projects, Programs and Services budget Fund No. 100000, as follows: \$5,000 from Cost Center 1105110005, and \$5,000 from Cost Center 1107110007 to provide funds for the above-referenced agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.
