Haight, Brown & Bonesteel LLP for the purposes of the defense of the civil litigation against Mr.

Arevalos, for an additional amount up to \$60,000.00 from the Public Liability Fund 720045,

solely and exclusively for the purpose of providing funds for the above-described legal services

and litigation expenses, bringing the total contract request to \$310,000.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized and

empowered to appropriate up to an additional \$60,000.00 from the Public Liability Fund to meet

this obligation.
