- 1. The sum of \$55,000 to be paid from the Public Liability Fund 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.
- 2. The Comptroller to issue a check in the amount of \$55,000 payable to Pacific Trial Lawyers and Kim Preciado.
