A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SALE OF CITY-OWNED LAND IN CITY HEIGHTS TO NEW CREATION CHURCH OF SAN DIEGO AND WAIVE COUNCIL POLICY 700-06.

WHEREAS, the City of San Diego (City) has owned certain real property known as Chollas Parkway Park since April 1, 1953; and

WHEREAS, in 2012, the City's Park & Recreation Department requested dedication status of the Chollas Parkway Park for park and recreation purposes, and the City's Real Estate Assets Department identified an encroachment on a portion of the Chollas Parkway Park requiring further investigation, thus removing it from the list of properties to be dedicated; and

WHEREAS, it was determined that the encroached portion of the Chollas Parkway Park had been incorporated into the large parking lot belonging to the New Creation Church of San Diego (NCCSD); and

WHEREAS, NCCSD acquired its property in 1993 from a previous church entity who originally developed its property, and who inadvertently incorporated a portion of Chollas Parkway Park into its parking lot; and

WHEREAS, the most prudent way to cure the encroachment and allow for the eventual dedication of the Chollas Parkway Park, is to sell a portion of Assessor's Parcel Number 477-240-11, consisting of approximately 14,503 square feet of land located at an adjoining area of Chollas Parkway Park and 3115 Altadena Avenue (Property), to the NCCSD;

WHEREAS, in accordance with Council Policy number 700-10, an exclusively negotiated sale is justified when the sale is to a contiguous owner to correct a site deficiency; and

WHEREAS, a real estate broker's commission will not be paid in the sale of the Property; and

WHEREAS, the Property was appraised by an independent MAI appraiser and the fair market value of the Property was determined to be Fifty One Thousand Dollars (\$51,000) and the appraiser used a November 20, 2012 "Date of Value," and said appraisal was reviewed by the City's Principal Appraiser on February 6, 2015, to form an opinion whether there has been a change in value since the "Date of Value" and the City's Principal Appraiser found that there has been no change in value of the Property; and

WHEREAS, the City's Principal Appraiser determined that NCCSD would expend approximately Five Thousand Dollars (\$5,000) for the cost of merging the Property to its adjacent property; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that approximately 14,503 square feet of City-owned real property in City Heights (a portion of APN 477-240-11), may be sold by direct negotiation to a contiguous owner to correct a site deficiency; and

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute and deliver the Purchase and Sale Agreement on file in the Office of the City Clerk as Document No. RR-309536 and

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to sell approximately 14,503 square feet of City-owned real property in City Heights (a portion of APN 477-240-11) to the New Creation Church of San Diego pursuant to the terms and conditions of that certain Purchase and Sale Agreement on file in the Office of the City Clerk as Document No. RR-309536 for the price of Forty Six Thousand Dollars (\$46,000); and

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to execute and deliver all such agreements and all other instruments to effect and complete the transaction contemplated by this Resolution; and

BE IT FURTHER RESOLVED, that Council Policy 700-06, Encroachments on City Property, is hereby waived; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept and deposit the proceeds of the sale of the property, net of escrow costs related to the sale, into the Capital Outlay Fund 400002.
