DATE OF FINAL PASSAGE MAR 25 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR AND CHIEF FINANCIAL OFFICER TO ACCEPT, APPROPRIATE, AND EXPEND GRANT FUNDS FROM THE SAN DIEGO COUNTY LAW ENFORCEMENT FOUNDATION (SDCLEF) IN THE AMOUNT OF \$12,371 IN FISCAL YEAR 2015, AND ANY ADDITIONAL FUNDS THAT MAY BE AWARDED THROUGH AMENDMENTS, EXTENSIONS OR RENEWALS FOR FISCAL YEARS 2015-2019.

WHEREAS, the San Diego County Law Enforcement Foundation (SDCLEF) is a non-profit 501(c)(3) corporation composed of community members dedicated to providing financial support to the San Diego County's Sheriff's Department and police departments in the County; and

WHEREAS, financial support is distributed in the form of grants for the purchase of equipment, continuing education scholarships, family assistance funds for families of officers killed in the line of duty, and other programs deemed worthy by the SDCLEF; and

WHEREAS, the City received an award in the amount of \$12,370.84 for Fiscal Year 2015; and

WHEREAS, these grant funds will be used to purchase equipment for the San Diego Police Department (Department) including one body wire with accessories, one computer for investigations on computers and cell phones, and three automated external defibrillators (AEDs) with hard cases; and

WHEREAS, the purchase of this equipment does not obligate the City to future expenditures or services; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to apply for and accept grant funding authorized by the San Diego County Law Enforcement Foundation (SDCLEF) in the amount of \$12,370.84 for Fiscal Year 2015.

BE IT FURTHER RESOLVED, that the Mayor or his representative is authorized to apply for and accept funding authorized by the SDCLEF, including any amendments, extensions, or renewals for a period of up to five years from Fiscal Year 2015 through and including Fiscal Year 2019, Fund 600002, provided funding is secured and made available by the SDCLEF.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend funding authorized by the SDCLEF including any amendments, extensions, or renewals for a period of up to five years from Fiscal Year 2015 through and including Fiscal Year 2019, Fund 600002, provided funding is secured and made available by the SDCLEF.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for the grants, if required.

BE IT FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate this program.

BE IT FURTHER RESOLVED, that the Mayor or his representative, including the Chief of Police, may certify that the City of San Diego will comply with all applicable statutory or regulatory requirements related to this grant program.
