A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE TRANSFER OF FUNDS TO CRYSTAL PIER IMPROVEMENTS PROJECT FOR REPAIRS TO THE CITY OWNED PORTION OF THE PIER.

WHEREAS, the Crystal Pier (Pier) is located in the Pacific Beach Community of San Diego and is jointly owned by the Crystal Pier Hotel (Hotel) and the City of San Diego (City); and

WHEREAS, recent field evaluations of the Pier identified the need for structural improvements along the entire length of the Pier; and

WHEREAS, the cost of structural improvements on the City-owned sections of the Pier identified in the survey is estimated at \$1,250,000 of which \$500,000 has already been appropriated in the project leaving a \$750,000 funding gap; and

WHEREAS, this action will authorize the needed funding to complete the structural repairs at the Pier; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Chief Financial Officer is authorized to transfer an amount of \$250,000 from the General Fund, Fund 100000, Department 9912, Citywide Program Expenditures, to Fund 400265, General Fund Contributions to the CIP; and
- 2. The Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S11014, Crystal Pier Improvements, and to appropriate an amount of \$250,000 from Fund 400265, General Fund Contributions to the CIP; and

- The Chief Financial Officer is authorized to transfer appropriations of \$500,000 3. from CIP A-BT.00001, City Facility Improvements, Fund 400848, Deferred Maintenance 2012A-Project Bonds Fund to CIP S11014, Crystal Pier Improvements; and
- 4. The Chief Financial Officer is authorized to expend \$500,000 from Fund Number 400848, Deferred Maintenance 2012A-Project Bonds Fund, and \$250,000 from Fund Number
