A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF FUNDS CONTINGENT ON A FULLY EXECUTED GRANT AGREEMENT WITH THE SAN DIEGO ASSOCIATION OF GOVERNMENTS (SANDAG) FOR GRANTVILLE TROLLEY STATION/ALVARADO CREEK ENHANCEMENT PROJECT.

WHEREAS, pursuant to Resolution R- 309556, the City Council authorized the application to SANDAG for grant funds for various projects, including the Grantville Trolley Station/Alvarado Creek Enhancement Project; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorized to appropriate and expend up to \$100,000 in Grantville Master Plan funds, Fund 200609 contingent upon a fully executed grant agreement for the Grantville Trolley Station/Alvarado Creek Enhancement Project.

BE IT FURTHER RESOLVED, that, if a grant award is made by SANDAG to fund Grantville Trolley Station/Alvarado Creek Enhancement Project, City of San Diego commits to providing \$100,000.
