BE IT RESOLVED, by the City Council of the City of San Diego, authorizing the Mayor or his representative to enter into a subgrantee agreement with Civic San Diego for the Euclid + Market Smart Growth Village Center, if awarded, for performance of services pursuant to the Agreement for Consulting Services by and between the City of San Diego and Civic San Diego, Document No. RR-307537-2, contingent upon Civic San Diego agreeing to accept all responsibilities under the grant agreement, for which the Environmental Protection Agency will provide a \$35,000 and the Jacobs Center for Neighborhood Innovation will provide a \$65,000 in matching funds, contingent upon a fully executed grant agreement.
