A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AND ESTABLISHING THE SOUTH PARK BANNER DISTRICT.

WHEREAS, section 142.1210(b)(5)(C) of the Municipal Code of the City of San Diego allows the placement of banners promoting cultural or civic events or activities of general public interest on streets and public rights-of-way designated by resolution of the City Council; and

WHEREAS, the South Park Banner District wishes to install street banners in the public right-of-way promoting cultural and civic events, and community activities of general public interest; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

- 1. In accordance with San Diego Municipal Code section 142.1210(b)(5)(C), the South Park Business Group may install banners in the following locations: (a) along east and west sides of Fern Street from Juniper to Beech Street and (b) along the east and west sides of 30th Street from Juniper to Ash Street.
  - 2. The banners shall be installed in accordance with the following:
- a. The banners shall not be used for commercial or political advertising, except that logos and trademarks of sponsoring organizations shall be permitted.
- b. The total area of logos and trademarks shall be limited to five percent of the banner area.
- c. The banners shall be displayed for no more than thirty calendar days, with one thirty-calendar day extension.

- d. The banners shall be installed only on light standards that have been equipped by the City with mounting hardware.
- e. The banners have been received all necessary permits to locate in the public right-of-way.
