A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING STREET NAME CHANGE FROM  
LISE AVENUE TO LAKIBA PALMER AVENUE.

WHEREAS, this street name change proposal is located east of Interstate 805, south of Interstate 94 and north of Market Street; and

WHEREAS, Lise Avenue is approximately 1,200 feet in length and serves approximately 34 single-family homes within a residential neighborhood in the Southeast San Diego Planned District SF-5000 Zone and the Encanto Community Plan; and

WHEREAS, the project proposes to change the name of Lise Avenue to Lakiba Palmer Avenue. Lakiba was killed on October 12, 2000, while serving on the USS Cole in Yemen and received the Purple Heart Medal; and

WHEREAS, this proposed street name change complies with all the criteria established by San Diego Municipal Code (SDMC) Section 125.1120; and

WHEREAS, SDMC Section 125.1120 is the established procedure governing proposed street name changes. A petition was circulated and forty-five signatures were obtained; and

WHEREAS, this does not represent 100 percent support of all affected property owners, therefore a decision by the City Council is required per SDMC Section 125.1110(b)(2); and

WHEREAS, the request has been processed in accordance with Process Five, except that a Planning Commission recommendation hearing is not required prior to a City Council decision;

NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the name of Lise Avenue, more particularly shown on Drawing No. 38459-B, attached hereto as Exhibit "A," is changed to Lakiba Palmer Avenue.

2. That the City Clerk shall cause a certified copy of this resolution, with Exhibit "A," attested under seal, to be recorded in the Office of the County Recorder.

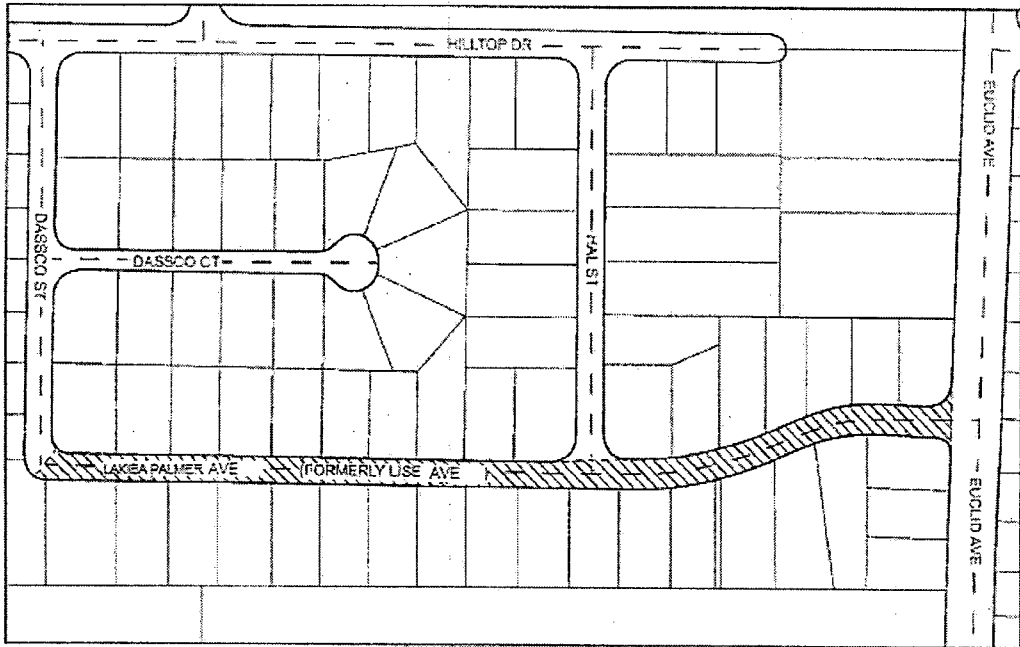
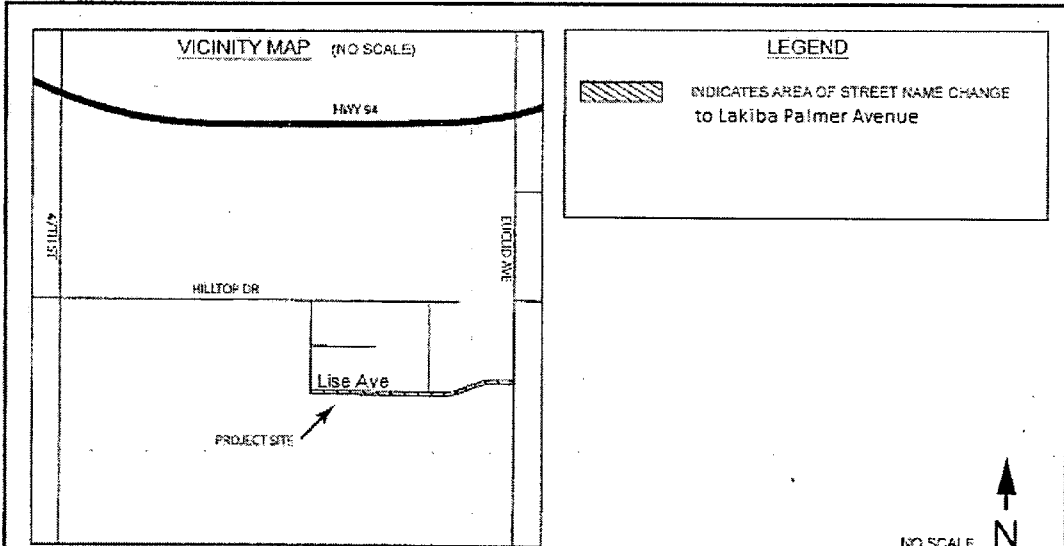
