A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO VACATING A SLOPE EASEMENT (EASEMENT VACATION NO. 1088120), A DRAINAGE EASEMENT (VACATION NO. 1289079), A SLOPE AND EMBANKMENT EASEMENT (VACATION NO. 1289084), AND DRAINAGE AND EMBANKMENT SLOPE EASEMENT (VACATION NO. 1430538) LOCATED EAST OF MIRA SORRENTO PLACE AND NORTH OF VISTA SORRENTO PARKWAY – PROJECT NO. 310632.

WHEREAS, California Streets and Highways Code section 8320 *et seq.* and San Diego Municipal Code section 125.1001 *et seq.* provide a procedure for the vacation of public service easements by City Council resolution; and

WHEREAS, San Diego Gas and Electric (SDG&E) filed an application to vacate a slope easement granted per Document No. 2003-1162339, recorded September 22, 2003, O.R, being described as Easement Vacation No. 1088120, a drainage easement granted per Document No. 2003-1162340, recorded September 22, 2003, O.R., being described as Easement Vacation No. 1289079, a slope and embankment easement granted per Document No. 1991-0340938, recorded July 11, 1991, O.R., being described as Easement Vacation No. 1289084), and a drainage and embankment slope easement granted per Document No. 318551, recorded November 29, 1972, O.R., being described as Easement Vacation No. 1430538; and

WHEREAS, Easement Vacation Nos. 1088120, 1289079, 1289084, and 1430538 are lying within a Portion of Lot 34 of Sorrento Lands and Townsite, Map No. 483 owned by SDG&E and located east of Mira Sorrento Place and north of Vista Sorrento Parkway; and

WHEREAS, under Charter Section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public

hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

WHEREAS, the matter was set for public hearing on APR 07 2015, testimony having been heard, evidence having been submitted, and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that with respect to Easement Vacation No. 1088120, Easement Vacation No. 1289079, Easement Vacation No. 1289084, and Easement Vacation No. 1430538, the Council finds that:

(a) There is no present or prospective public use for the easement, either for the facility or purpose for which it was originally acquired, or for any other public use of a like nature that can be anticipated.

The existing easements were recorded for the construction of public rights-of-way for Vista Sorrento Parkway and Mira Sorrento Place. Vista Sorrento Parkway and Mira Sorrento Place have been fully constructed and the easements are no longer required for roadway purposes. The excess public service easements are within one ownership and do not extend beyond that ownership or touch the property of another owner. Vista Sorrento Parkway and Mira Sorrento Place have been constructed to their ultimate width and consistent with the Transportation element of the Mira Mesa Community Plan; therefore, there is no other present or prospective public use for the remaining easements or any other public use of a like nature that can be anticipated.

(b) The public will benefit from the action through improved utilization of the land made available by the vacation.

The existing easements lie within a Portion of Lot 34 of Map No. 483 and located east of Mira Sorrento Place and north of Vista Sorrento Parkway. The property is owned by SDG&E on which the Mira Sorrento Substation is constructed. Vista Sorrento Parkway and Mira Sorrento Place have been fully constructed and the easements to be vacated are no longer required for purposes for which they were acquired. The vacations will remove the maintenance and liability of the remaining easements from the City of San Diego, and will allow the potential for the improved use of land made available for the vacation.

(c) The vacation is consistent with any applicable land use plan.

The easement vacations would not adversely affect the Mira Mesa Community Plan which calls for providing and maintaining essential facilities and infrastructure to serve existing and future development. Since the easements were recorded for the construction of public rights-of-way for Vista Sorrento Parkway and Mira Sorrento Place and the construction of the rights-of-way have since been completed to the ultimate widths pursuant to the community plan with no future street widening anticipated; the proposed vacations are consistent with and maintain the requirements of the Mira Mesa Community Plan.

(d) The public facility or purpose for which the easement was originally acquired will not be detrimentally affected by the vacation or the purpose for which the easement was acquired no longer exists.

The existing easements that lie within a Portion of Lot 34 of Map No. 483 and located east of Mira Sorrento Place and north of Vista Sorrento Parkway, allowed for the temporary

construction, repair, and maintenance of slopes and drainage facilities, associated with the construction of Vista Sorrento Parkway and Mira Sorrento Place. The purpose and intent for which the easements were originally acquired, have been met and the anticipated improvements have been constructed. Therefore, the purpose for which the easements were originally acquired no longer exist and will not be detrimentally affected by the proposed vacations.

BE IT FURTHER RESOLVED, Easement Vacation No. 1088120, as more particularly described in the legal description marked as Exhibit "A-1" and shown on Drawing No. 37373, marked as Exhibit B-1," which are by this reference incorporated herein and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED, Easement Vacation No. 1289079, as more particularly described in the legal description marked as Exhibit "A-2" and shown on Drawing No. 38023, marked as Exhibit "B-2," which are by this reference incorporated herein and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED, Easement Vacation No. 1289084, as more particularly described in the legal description marked as Exhibit "A-3" and shown on Drawing No. 38024, marked as Exhibit "B-3," which are by this reference incorporated herein and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED, Easement Vacation No. 1430538, as more particularly described in the legal description marked as Exhibit "A-4" and shown on Drawing No. 38400, marked as Exhibit "B-4," which are by this reference incorporated herein and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED, the Development Services Department shall record a certified copy of this resolution with attached exhibits, attested by the City Clerk under seal, in the office of the County Recorder.
