WHEREAS, the Independent Budget Analyst convened a screening committee, as required by Charter section 39.1, for purposes of filling this vacancy; and

WHEREAS, the screening committee met on March 4, 2015, and identified six candidates who are qualified to serve as public committee members on the Audit Committee; and

WHEREAS, the City Council has interviewed said candidates and confirmed the appointment of one of these candidates to the Audit Committee for a four-year term; and

WHEREAS, under Charter section 280(a)(6) the Council appointment of members of the Audit Committee is not subject to veto by the Mayor; NOW, THEREFORE,
