A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AND RATIFYING AN AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE SAN DIEGO CITY FIREFIGHTERS, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 145 REGARDING TERMS AND CONDITIONS OF EMPLOYMENT FOR FISCAL YEARS 2014 THROUGH 2018.

WHEREAS, on October 1, 2013, by San Diego Resolution R-308478 (Oct. 15, 2013), the San Diego City Council (Council) approved a Memorandum of Understanding (MOU) between the City of San Diego (City) and the San Diego City Firefighters, International Association of Firefighters, Local 145 (Local 145) regarding terms and conditions of employment for Fiscal Years 2014 through 2018; and

WHEREAS, Article 22 of the MOU relates to the Flexible Benefits Plan; and WHEREAS, Paragraph B of Article 22 sets forth the annual allotment for the City's Flexible Benefit Plan, with different allotment amounts for Local 145 employees depending on whether they purchase health insurance for themselves only or themselves and family members, or purchase health coverage outside of the City's plans; and

WHEREAS, Local 145 has requested that the allotment amounts be amended, effective July 1, 2016, in a way that will not increase the cost to the City of Local 145's flexible benefits; and

WHEREAS, the City and Local 145 have reached a tentative agreement to amend Paragraph B of Article 22 to reflect the negotiated modifications; and

WHEREAS, under the Meyers-Milias-Brown Act (MMBA), the state law related to collective bargaining between the City and its represented employees, and Council Policy 300-06, it is within the discretion of the Council to approve and ratify the negotiated agreement related to the Flexible Benefits Plan allotment amounts; and

WHEREAS, the Council desires to approve and ratify the agreement, which amends

Article 22 of the MOU on the terms and conditions set forth in the agreement; NOW,

THEREFORE,

BE IT RESOLVED that, pursuant to the authority of the MMBA and Council Policy 300-06, the Council of the City of San Diego approves and ratifies the agreement between the City and Local 145 to amend Paragraph B of Article 22 of the MOU, on file in the office of the City Clerk as Document No. \$\frac{12-309631}{209631}\$.
