A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE THAT CERTAIN CONCESSION AGREEMENT BY AND BETWEEN THE CITY OF SAN DIEGO, SAN DIEGO SPORTSERVICE, INC., AND DELAWARE NORTH COMPANIES SPORTSERVICE, INC., FOR THE PROVISION OF FOOD AND BEVERAGE SERVICES AT QUALCOMM STADIUM.

WHEREAS, the City of San Diego (City) issued Request for Proposal (RFP) No. 10054790-15-C seeking a concessionaire to provide food and beverage services at Qualcomm Stadium. Delaware North Companies Sportservice, Inc. (DNS) was the successful proposer under said RFP;

WHEREAS, DNS requested the right to transfer its interest in the proposed concession contract (hereinafter referred to as the "Concession Agreement") to its wholly-owned subsidiary, San Diego Sportservice, Inc. (Sportsservice), if awarded the Concession Agreement. As an inducement to allow the transfer to Sportsservice, DNS has agreed, as part of the Concession Agreement, to be a Guarantor for all amounts owed the City and for the full and timely performance of all of Sportsservice's other obligations under the Concession Agreement;

WHEREAS, the City desires to engage Sportsservice to provide food and beverage services at the Stadium;


WHEREAS, Sportsservice desires to provide the food and beverage services for the City; and

WHEREAS, City staff now seeks the City Council's authorization for the Mayor, or his designee, to execute the Concession Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Mayor, or his designee, is authorized to execute, and take all actions necessary to administer, that certain Concession Agreement by and between the City of San Diego, San Diego Sportservice, Inc., and Delaware North Companies Sportservice, Inc., under the terms and conditions set forth in the Concession Agreement, on file in the Office of the City Clerk as Document No RR-309636.




