A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO THE ALLIANCE FOR QUALITY EDUCATION FOR THE D6 NIGHT MARKET, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Alliance for Quality Education (Alliance) has requested funding for the D6 Night Market, a free, family-friendly, open-air street market, featuring vendors that exhibit local and cultural fares with a significant emphasis on food; and

WHEREAS, the requested funding will be used for overall event support: marketing, advertising, outreach and promotional materials; event entertainment stage, audio/visual, and lighting; electrical generators; security fencing and barricades; portable restrooms and hand-washing stations for attendees; utility sinks for vendors; tables, chairs, and tents; dumpsters and recycling bins; traffic, security, and safety personnel; site clean-up services; permits; insurance; and

WHEREAS, the Alliance's request for funding for the D6 Night Market will benefit the six neighborhoods that comprise of Council District 6 by highlighting local food and merchandise vendors while also providing a platform to showcase local entertainers and cultural groups; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 6 recommends an allocation of \$10,000 to the Alliance for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Alliance for Quality Education (Agreement) in an amount not to exceed \$10,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-309653.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1106110006, to provide funds for the above-referenced

Agreement, contingent upon the Chief Financial O	fficer first furnishing one or more certificates
certifying that the funds necessary for expenditure	are, or will be, on deposit with the City
Treasurer.
