A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGOAPPROVING SETTLEMENT OF MICHELLE DAVIS AND NICOLE JOHNSON

WHEREAS, on June 18, 2014, Plaintiffs Michelle Davis and Nicole Johnson filed suit against the City of San Diego [City] alleging personal injuries arising from their interaction with former San Diego Police Officer Christopher Hays which occurred on November 4, 2012 and July 13, 2012, respectively. The suit is entitled *Michelle Davis, Claudia Ariza and Nicole Johnson v. City of San Diego and Christopher R. Hays*, Case No. 14cv1488 DMS (DHB); and

WHEREAS, in closed session on March 17, 2015, the City Council, by the following votes:

Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, District 8, approved the settlement of Michelle Davis and Nicole Johnson's claims for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

- 1. The Mayor or his designee to pay the sum of \$1,250,000 from the Public Liability Fund 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Michelle Davis, United States District Court Case No. 14cv1488 DMS (DHB).
- 2. The Mayor or his designee to pay the sum of \$60,000 from the Public Liability Fund 720045, in settlement of each and every claim for damages, interest, costs, and fees of any

type, including attorney fees, against City of San Diego, its agents and employees, arising from

the personal injury claim of Nicole Johnson, United States District Court Case No. 14cv1488

DMS (DHB).

The Chief Financial Officer to appropriate and expend \$1,310,000 from the 3.

Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or

more certificates certifying that the funds necessary for expenditure are, or will be, on deposit

with the City Treasurer;
