A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE INSTALLATION OF ANGLE PARKING ALONG ARIZONA STREET AND LOUISIANA STREET.

WHEREAS, the Transportation Engineering Operations Division of the Transportation and Stormwater Department has reviewed a petition from property owners requesting angle parking along the west side of Arizona Street between University Avenue and Lincoln Avenue and the east side of Louisiana Street between University Avenue and Lincoln Avenue; and

WHEREAS, the Transportation Engineering Operations Division has calculated that the requested angle parking will result in 13 additional parking spaces on the west side of Arizona Street between University Avenue and Lincoln Avenue and 23 additional parking spaces on the east side of Louisiana Avenue between University Avenue and Lincoln Avenue; and

WHEREAS, the City of San Diego will install striping for the angle parking spaces at a cost of \$21,155; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- In accordance with San Diego Municipal Code section 86.0104 and California
 Vehicle Code section 22503, the installation of angle parking is authorized on Arizona Street and
 Louisiana Street.
- 2. In accordance with San Diego Municipal Code section 86.0104 and California Vehicle Code section 22503, the installation of necessary signs and markings for such angle parking is authorized, and the regulations shall become effective upon installation of the signs.

3. The expenditure of \$21,155 from Street Division General Fund No. 100000, 211611, Transportation and Storm Water Department Streets Division, is authorized, solely and exclusively to provide funds for the necessary work by City forces relating to installation of angle parking on Arizona Street and Louisiana Street.
