DATE OF FINAL PASSAGE MAY 12 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE CITY OF SAN DIEGO'S
FISCAL YEAR 2016 ANNUAL ACTION PLAN AND
AUTHORIZING SUBMISSION TO THE U.S. DEPARTMENT
OF HOUSING AND URBAN DEVELOPMENT.

WHEREAS, the City of San Diego's (City) Fiscal Year 2015-2019 Consolidated Plan (Consolidated Plan) continues the City's consolidated process for four U.S. Department of Housing and Urban Development (HUD) housing and community development formula-based programs: Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), Emergency Shelter Grant (ESG), and Housing Opportunities for Persons with AIDS (HOPWA); and

WHEREAS, the Consolidated Plan describes how the City is meeting statutory requirements of specified federal grant programs which set forth three basic goals, each of which must primarily benefit low and moderate income persons: (1) to provide decent housing; (2) to provide a suitable living environment, and (3) to expand economic opportunities; and

WHEREAS, the Fiscal Year 2016 Annual Action Plan (Action Plan), included in the backup materials accompanying this Resolution, represents the second year of the City's Consolidated Plan as approved by HUD and the consolidated planning requirements for the CDBG, HOME, ESG, and HOPWA programs; and

WHEREAS, the City will be applying to receive an amount not to exceed \$18,794,909 in Fiscal Year 2016 to be used for public services and facilities, economic development activities, and affordable housing opportunities; and

WHEREAS, the City will be utilizing Fiscal Year 2015 CDBG program income in the amount of \$60,658 to fund Fiscal Year 2016 CDBG activities; and

WHEREAS, the City must report this Fiscal Year 2015 program income used for Fiscal Year 2016 CDBG activities as part of the Action Plan; and

WHEREAS, the Action Plan describes how the City is meeting the statutory requirements of specified federal grants programs to meet the three basic goals set forth above and also serves as the Fiscal Year 2016 funding application for HUD funds in the amount of approximately \$18,794,909 (which includes \$11,026,482 in CDBG, \$3,963,370 in HOME, \$978,583 in ESG, and \$2,826,474 in HOPWA); and


WHEREAS, the Action Plan describes how the City's community development strategy will continue to rely on a multi-faceted approach to meeting said goals through a partnership comprised of the public and private sector and nonprofit entities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council approves the City's federally required Action Plan, a copy of which shall be placed on file in the Office of the City Clerk as Document No. RR- 309667.

2. The Mayor or designee is authorized to coordinate final revisions to the Action Plan to ensure that approved activities and all public comments received during the 30-day public comment period are included in the final Action Plan and submitted in a timely manner to the U.S. Department of Housing and Urban Development for its review and approval.
