A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE PRIORITY OF CAPITAL IMPROVEMENT PROJECTS AND ALLOCATING FISCAL YEAR 2014 REGIONAL PARK IMPROVEMENT FUNDS INTO VARIOUS CIP PROJECT FUNDS.

WHEREAS, the San Diego Regional Park Improvement Fund (RPIF) supports capital improvement projects in San Diego Regional Parks defined in San Diego City Charter section 55.2, as including Chollas Lake Park, Balboa Park, Mission Trails Regional Park, Otay River Valley Park, Presidio Park, San Diego River Park, open space parks, and coastal beaches along with coastal parks contiguous thereto; and

WHEREAS, \$3,100,000 is currently available in the Regional Park Improvement Fund to be transferred to capital improvement projects in San Diego Regional Parks pursuant to Charter section 55.2, which consists of \$2,500,000 from Fiscal Year 2014 Mission Bay Park lease revenues and an additional \$600,000 carried over from previous years; and

WHEREAS, on November 20, 2014, the Regional Park Improvement Fund Oversight Committee heard and recommended the following capital improvements be prioritized and allocated Fiscal Year 2014 Regional Park Improvement Funds: (i) foundation reconstruction in the Hall of Nations building in Balboa Park; (ii) replacement of the comfort stations in the west mesa of Balboa Park; (iii) replacement of the comfort station in Ellen Browning Scripps Park; (iv) accessibility improvements at the Junipero Serra Museum in Presidio Park; and (v) hillside improvements in Sunset Cliffs Natural Park; and

WHEREAS, on November 20, 2014, the Regional Park Improvement Fund Oversight Committee heard and recommended prioritizing the following capital improvements for receipt of Fiscal Year 2015 Regional Park Improvement Funds, which funds are proposed to be allocated in Fiscal Year 2016: (i) accessibility improvements at the Junipero Serra Museum in Presidio Park; (ii) restoration of the Mohnike Adobe and Hay Barn in Los Penasquitos Canyon Preserve; (iii) phase one of drainage improvements in Sunset Cliffs Natural Park; and (iv) slope stabilization and reconstruction of storm water conveyance in Soledad Natural Open Space Park on the north side of La Jolla Parkway; and

WHEREAS, there is a small amount of funding that is available in the Regional Park Improvement Fund that pre-dates adoption of Charter section 55.2; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that pursuant to Charter section 55.2(d), the recommendation of the Regional Park Improvement Fund Oversight Committee prioritizing the capital improvement projects in regional parks to be allocated Regional Park Improvement Funds generated in Fiscal Year 2014 and Fiscal Year 2015, is hereby approved.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$250,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP ABT-00001, Annual Allocation – City Facilities Improvements within Fund 200391, Regional Park Improvement Fund, for the purpose of reconstructing the foundation of the Hall of Nations building in Balboa Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to add CIP S-15036, Balboa Park West Mesa Comfort Station Replacement, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$1,000,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP S-15036, Balboa Park West Mesa Comfort Station Replacement within Fund 200391, Regional Park Improvement Fund, for the purpose of replacing two comfort stations located on the west mesa area of Balboa Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to add CIP S-15035, Ellen Browning Scripps Park Comfort Station Replacement, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$250,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP S-15035, Ellen Browning Scripps Park Comfort Station Replacement, within Fund 200391, Regional Park Improvement Fund, for the purpose of replacing the comfort station adjacent to La Jolla Cove in Ellen Browning Scripps Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to add CIP S-15034, Junipero Serra Museum ADA Improvements, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$500,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP S-15034, Junipero Serra Museum ADA Improvements within Fund 200391, Regional Park Improvement Fund, for the purpose of improving accessibility to the Junipero Serra Museum in Presidio Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$50,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP S-10026, Palisades Park Comfort Station Replacement within Fund

200391, Regional Park Improvement Fund, for the purpose of replacing the comfort station at Palisades Park at the western end of Law Street in Pacific Beach.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$1,100,000 from CIP AGF-00005, Annual Allocation Regional Park Improvements, to CIP S-10091, Sunset Cliffs Natural Park Hillside Improvements within Fund 200391, Regional Park Improvement Fund, for the purpose of improving the hillside portions of Sunset Cliffs Natural Park.
