BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorized to transfer appropriations of \$6,743.46 from Annual Allocation AEA-00002, Balboa Park Golf Course/B-11100, Balboa Park Golf Course Concrete Improvements to Capital Improvement Projects to project S-00767, Wightman Street Neighborhood Park within Fund 400265, General Fund Contributions, for the purpose of constructing the new Wightman Street Neighborhood Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-00767, Wightman Street Neighborhood Park, and to appropriate and expend \$287,402 contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit

with the City Treasurer from Fund 200109, Environmental Growth Fund Two-Thirds, for the purpose of constructing the new Wightman Street Neighborhood Park.
