A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN APPLICATION TO THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY, FEDERAL EMERGENCY MANAGEMENT AGENCY FOR A PRE-DISASTER MITIGATION GRANT FOR THE SEISMIC RETROFIT OF CALIFORNIA TOWER IN BALBOA PARK AND RELATED ACTIONS.

WHEREAS, the United States Department of Homeland Security, Federal Emergency

Management Agency (FEMA) administers a Pre-Disaster Mitigation Program that provides grant

funding for hazard mitigation planning and projects; and

WHEREAS, the City's receipt of this funding depends on the City's ability to identify an applicable pre-disaster mitigation project and submit a qualifying application; and

WHEREAS, the California Tower was constructed in Balboa Park in 1914 and requires seismic upgrades to bring the tower structure up-to-date with the applicable building code; and

WHEREAS, subject to City Council approval, City staff would apply to FEMA for a Pre-Disaster Mitigation Program grant in the amount of \$1,000,000 for the seismic retrofit of the California Tower in Balboa Park; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his representative is authorized to make an application to FEMA and to take all necessary actions to secure funding for an amount not to exceed \$1,000,000 in Pre-Disaster Mitigation Program funds for the seismic retrofit of the California Tower in Balboa Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate, and expend an amount not to exceed \$1,000,000 if the Pre-Disaster Mitigation Program grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP L-12003, California Tower Seismic Retrofit, and to appropriate and expend \$1,000,000 contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit with the City Treasurer from Fund 600000, Federal Emergency Management Agency Pre-Disaster Mitigation Program, for the purpose of seismically retrofitting the California Tower in Balboa Park, contingent upon a fully executed grant agreement.
