DATE OF FINAL PASSAGE MAY 2 8 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO CREATE NEW PROJECTS WITHIN THE CAPITAL IMPROVEMENT PROGRAM AND TO ALLOCATE AND EXPEND MISCELLANEOUS FUNDING SOURCES FOR NEW AND EXISTING CAPITAL PROJECTS, TO RENAME THE MID-CITY SKATE PARK CAPITAL PROJECT, AND TO DE-ALLOCATE FUNDING FOR THREE EXISTING CAPITAL PROJECTS.

WHEREAS, the City is initiating accessibility improvements at Doyle Community Park that are proposed to be funded, in part, with fees associated with wireless facilities on certain City properties and deposited into the Antenna Lease Revenue Fund; and

WHEREAS, the City is undertaking improvements and updates to the North Course at Torrey Pines Golf Course in order to enhance the playability of the course, improve course conditions and update the irrigation system, which improvements are proposed to be funded by the Golf Enterprise Fund from revenue from operation of the City's three golf courses; and

WHEREAS, the City is proposing infrastructure improvements at Hickman Field Athletic Area, including irrigation, drainage, parking lots, a recreation center and an aquatic complex, proposed to be funded, in part, with developer funds; and

WHEREAS, the Park and Recreation Department proposes to rename CIP S-15003, Mid-City Skate Park, to "Park de la Cruz Neighborhood Park Improvements" in order to expand the scope of the project to improvements to the entire park; and

WHEREAS, the City is initiating the construction of accessibility upgrades to the children's play area and associated paths of travel at Skyline Hills Community Park; and

WHEREAS, the Park and Recreation Department is requesting authority to deappropriate the budgets for the Southcrest Trails 252 Corridor Park Improvements Phase 2 project, the Larsen Field ADA Improvements Phase II project, and the Joint Use Improvements – Citywide project for revenue that is not available; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Chief Financial Officer is authorized to add CIP S-15037, Doyle Community Park ADA Upgrades, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-15037, Doyle Community Park ADA Upgrades, and to appropriate and expend \$400,000 contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit with the City Treasurer from Fund 200324, Park and Recreation Antenna Lease Revenue Fund, for the purpose of installing path of travel improvements at Doyle Community Park.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-00751, Hickman Athletic Area Improvements, and to appropriate and expend a total of \$544,854 contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit with the City Treasurer, of which \$37,310 is from Fund 400250, General Dynamics Community Improvement Fund, for general improvements to Hickman Athletic Area, and \$507,544 is from Fund 400259, Kearny Mesa 20% Improvements Fund, for general improvements to Hickman Athletic Area.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$946,730 from Fund 200636, Monetary Contributions Placed on Future

Development, 9913 – Citywide Other/Special Funds Department (Operating) to CIP S-00751, Hickman Athletic Area Improvements, for site preparation for the eventual recreation center and aquatic complex, and general improvements at Hickman Athletic Area.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to rename CIP S-15003, Mid-City Skate Park, as "Park de la Cruz Neighborhood Park Improvements."

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to add CIP S-15038, Skyline Hills Community Park ADA Improvements, to the Capital Improvements Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer appropriations of \$210,261.08 from CIP AGF-00001, Annual Allocation Park Grant Match, to CIP S-15038, Skyline Hills Community Park ADA Improvements ,within Fund 400265, General Fund Contributions to the CIP, for the purpose of improving accessibility to Skyline Hills Community Park, contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to increase the Capital Improvements Program Budget in CIP S-14019, Torrey Pines Golf Course – North Course Improvements, and to appropriate and expend \$2,000,000 contingent upon the Chief Financial Officer furnishing a certificate certifying that funds necessary for expenditure are or will be on deposit with the City Treasurer from Fund 700045, Golf Course Enterprise CIP Fund, for the purpose of improving the North Course at Torrey Pines Golf Course.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to reduce the Capital Improvement Program budget by de-appropriating a total amount of \$1,339,592.06, of which \$1,299,999.74 is from Fund 200353, Southerest Redevelopment Agency Contribution

in CIP S-01071, Southcrest Trails 252 Corridor Park Improvements Phase 2; \$0.32 is from Fund 400078, San Ysidro Park Service District in CIP S-13004, Larsen Field ADA Improvements Phase II; and \$39,592 is from Fund 600001, Grant Fund – State in CIP AGF-00003, Joint Use Improvements – Citywide, for the purpose of de-appropriating budget for revenue not available.
