A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO THE MISSION HILLS TOWN COUNCIL FOR SUMMER CONCERTS IN THE PARK, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Mission Hills Town Council has requested funding for the Summer Concerts in the Park; and

WHEREAS, the requested funding will be used to pay for the stage and sound production as well as for the bands and other costs associated with advertising and permits; and

WHEREAS, the Mission Hills Town Council's request for funding for the Summer Concerts in the Park will benefit the community by providing free summer music on a Friday evening at a local public park; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 3 recommends an allocation of \$5,000 to the Mission Hills

Town Council for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2015 City Council Allocations Agreement between the City of San Diego and the Mission

Hills Town Council (Agreement) in an amount not to exceed \$5,000 for the project described in

this resolution, under terms and conditions set forth in the Agreement on file in the Office of the

City Clerk as Document No. RR- 309688

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$5,000 from the Community Projects, Programs, and Services budget

Fund No. 100000, Cost Center 1103110003, to provide funds for the Agreement, contingent

upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.
