DATE OF FINAL PASSAGE MAY 28 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO THE PARADE BAND FOUNDATION, INC. FOR THE 38<sup>TH</sup> ANNUAL MT. CARMEL TOURNAMENT OF BANDS – BAND REVIEW, PURSUANT TO COUNCIL POLICY 100-06, “CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES.”

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled “City Council Funding of Community Projects, Programs and Services” on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Parade Band Foundation, Inc. has requested funding for the 38th Annual Mt. Carmel Tournament of Bands – Band Review; and

WHEREAS, the requested funding will be used for the San Diego Police Department (street closures/public safety), permits, competition adjudicators by Southern California School band Orchestra Association, public street signs, ambulance services, and truck rental for barricades, cones, delineators, portable toilets, and street signs; and

WHEREAS, the Parade Band Foundation, Inc.’s request for funding for the 38th Annual Mt. Carmel Tournament of Bands – Band Review, San Diego’s longest-running band review competition and one of Southern California’s oldest and most prestigious competitions, provides

a free to the public venue where the community can watch local bands, such as Mt. Carmel High School and up to thirty-five other bands, compete and showcase their musicianship, marching and maneuvering, and showmanship; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$5,000 to the Parade Band Foundation, Inc. for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Parade Band Foundation, Inc. (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309689.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1105110005, to provide funds for the Agreement, contingent

upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
