A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE 2015 LEGISLATIVE
CALENDAR.

WHEREAS, each year the City Council adopts a schedule of meetings for the City Council and Standing Committees of the City Council for the calendar year, commonly referred to as the legislative calendar; and

WHEREAS, on October 21, 2014, the Council adopted the 2015 Legislative Calendar; and

WHEREAS, the Council has previously amended the 2015 Legislative Calendar to modify certain dates as it deemed necessary; and

WHEREAS, the Council now wishes to amend the 2015 Legislative Calendar to change dates and times of additional meetings; and

WHEREAS, the Council seeks to make the following amendments to the 2015 Legislative Calendar through this resolution:


- Changing the start time of the Charter Review Committee meeting of May 14, 2015 from 2 p.m. to 2:30 p.m.;
- Changing the start time of the regularly scheduled City Council meeting of May 18, 2015 from 2 p.m. to 1 p.m.;
- Changing the start time of the Charter Review Committee meeting of June 11, 2015 from 2 p.m. to 6 p.m.;

- Adding a meeting of the Public Safety & Livable Neighborhoods Committee on November 12, 2015 at 2 p.m.; and
- Adjourning the meeting of the Public Safety & Livable Neighborhoods Committee previously set for December 9, 2015 at 2 p.m.; and

WHEREAS, under Charter section 280(a)(1) this resolution is not subject to veto by the Mayor, because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the 2015 Legislative Calendar is hereby amended as reflected in the revised 2015 Legislative Calendar, a copy of which is on file in the Office of the City Clerk as Document No. RR- 309692.
