A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$9,000 TO MISSION EDGE SAN DIEGO, INC. (MID-CITY CAN) FOR THE YOUTH OPPORTUNITY BUS PASS PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Mission Edge San Diego, Inc. on behalf of Mid-City CAN, has requested funding for the Youth Opportunity Bus Pass Program; and

WHEREAS, the requested funding will be used to match \$9,000 from San Diego County Supervisor Ron Roberts and \$200,000 from the San Diego Unified School District, and to purchase approximately 20 additional youth passes from the Metropolitan Transportation System in 2015; and

WHEREAS, the request for funding for the Youth Opportunity Bus Pass Program will benefit young people in San Diego to travel to-and-from work and school safely, as well as accessing jobs and extra-curricular activities normally not accessible to them; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 3, 8, and 9 recommend a total allocation of \$9,000 to Mission Edge San Diego, Inc. on behalf of Mid-City CAN for the purposes set forth in this resolution, attributed as follows: Council District 3 – \$3,000; Council District 8 – \$3,000; and Council District 9 –\$3,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and Mission Edge San Diego, Inc. on behalf of Mid-City CAN (Agreement) in an amount not to exceed \$9,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309700.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$3,000 from Council District 3: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1103110003; \$3,000 from Council District 8: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1108110008; and, \$3,000 from Council District 9: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1109110009, all to provide funds for the

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
