WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Jewish Family Service of San Diego (Jewish Family Service) has requested funding for the Northern San Diego Rides & Smiles Program; and

WHEREAS, the requested funding will be used to subsidize the cost of 1,375 rides for seniors and adults with disabilities utilizing the North San Diego Rides & Smiles Program; and

WHEREAS, Jewish Family Service's request for funding for the Northing San Diego Rides & Smiles Program will benefit San Diego's older adults with physical and mental disabilities by enabling seniors to access passenger-centered transportation services when and where needed with personalized assistance getting in and out of the vehicle; and

WHEREAS, this program reduces societal, governmental, and institutional costs by addressing the specific needs of older adults, including reduced isolation and improved quality of life and independent living; and

WHEREAS, it is the determination of the City Council that the above-described program

fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 1 recommends an allocation of \$23,000 to the Jewish

Family Service for the purposes set forth in this resolution; NOW, THEREFORE,
