DATE OF FINAL PASSAGE MAY 28 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$4,000 TO PAZZAZ, INC. FOR THE ALL-AMERICAN SOAPBOX DERBY, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, Pazzaz, Inc. has requested funding for the All-American Soapbox Derby; and

WHEREAS, the requested funding will be used to pay for a license and insurance, City of San Diego permits, including a permit from the San Diego Fire-Rescue Department, traffic control equipment, City traffic control officers, portable toilet rental, car decorations, and storage containers; and

WHEREAS, the request for funding for the All-American Soapbox Derby will benefit young people growing up in high-risk neighborhoods by giving them an opportunity to participate in a positive, out-of-school activity that encourages close adult-youth activities and mentoring, goal-setting and completion, and developing traits such as self-confidence, perseverance, craftsmanship, leadership and sportsmanship; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$4,000 to Pazzaz, Inc. for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and Pazzaz, Inc. (Agreement) in an amount not to exceed \$4,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- **309713**.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$4,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1108110008, to provide funds for the Agreement, contingent

upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


