A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$5,000 TO BAME RENAISSANCE, INC. FOR THE COMMUNITY GARDEN GATHERING PLACE, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, BAME Renaissance, Inc. (BAME) has requested funding for the Community Garden Gathering Place; and

WHEREAS, the requested funding will be used to purchase supplies to execute the community-build project (construction materials, plants, soil, tools, paint); hire professional artists, architects, designers, landscapers to help develop the design/site plan and assist volunteers in building their vision; water system (irrigation); soil testing; printing and marketing of promotional materials; lights, cameras, and locked storage sheds; food and water for volunteers; and

WHEREAS, BAME's request for funding for the Community Garden Gathering Place will have multiple community and public benefits: (1) community members will develop a grassroots project that reflects their needs and desires as they will be involved in all phases of the

project, from design through construction; (3) it will benefit local business owners by providing a space for customers to sit outside and enjoy their meal; (4) the public will have opportunities to learn about and participate in urban gardening, and to grow produce for their personal consumption and perhaps eventually to sell, which is of critical importance because the Greater Logan Heights neighborhood has very little access to fresh and affordable produce; and (5) local students will be active participants throughout the project, helping to conduct neighborhood outreach and engaging in hands-on STEAM education; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to BAME for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the BAME Renaissance Community Development Corporation (Agreement) in an amount not to exceed \$5,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-309718

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1108110008, to provide funds for the Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
