A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT THE APPROVAL OF THE AWARD OF FUNDS TO THE BAME RENAISSANCE COMMUNITY DEVELOPMENT CORPORATION FOR THE COMMUNITY GARDEN GATHERING PLACE IS CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT PURSUANT TO CEQA GUIDELINES SECTIONS 15301 AND 15304.

WHEREAS, the City of San Diego proposes to award Community Projects, Programs, and Services funding to the BAME Renaissance Community Development Corporation for the Community Garden Gathering Place project located on Imperial Avenue between 28th and 29th Streets (Project); and

WHEREAS, section 21084 of the California Environmental Quality Act (CEQA) (California Public Resources Code section 21000, *et. seq.*), states that the CEQA Guidelines (California Code of Regulations, Title 14, Chapter 3, section 15000, *et. seq.*) shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15300-15333 list the categorical exemptions promulgated by the California Office of Planning and Research and adopted by the Secretary of the California Natural Resources Agency for those classes of projects which have been determined not to have a significant effect on the environment; and

WHEREAS, the Development Services Department has established that the Project is categorically exempt from CEQA pursuant to CEQA Guidelines sections 15301(Existing Facilities) and 15304 (Minor Alterations to Land) and that no exception to the exemptions, as set forth in CEQA Guidelines section 15300.2, apply to the Project; and

WHEREAS, the San Diego City Council (Council) has considered the potential

environmental effects of the Project, and

WHEREAS, the Council held a duly noticed public meeting and considered the written

record for the Project as well as public comment; and

WHEREAS, the Council, using its independent judgment, has determined that the Project

will not have a significant effect on the environment as it is a minor temporary use of land

having negligible or no permanent effects on the environment; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego determines that the Project

is categorically exempt from CEQA pursuant to CEQA Guidelines section 15301, which allows

for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of

existing public or private structures or facilities involving negligible or no expansion of use, and

that an exception to the exemption does not apply.

BE IT FURTHER RESOLVED, that the Council Diego determines that the Project is

categorically exempt from CEQA pursuant to CEQA Guidelines section 15304(e) (Minor

Alterations to Land) which allows for minor temporary use of land having negligible or no

permanent effects on the environment.

BE IT FURTHER RESOLVED, that the Council has determined that an exception to the

exemption as set forth in CEQA Guidelines section 15300.2 does not apply.
