

RESOLUTION NUMBER R- 309720DATE OF FINAL PASSAGE MAY 28 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$12,000 TO THE NEW CHILDREN'S MUSEUM FOR THE MASS CREATIVITY PROJECT – 2015, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, The New Children's Museum (Children's Museum) has requested funding for the Mass Creativity Project – 2015; and

WHEREAS, the requested funding will be used to support workshops at Casa Familiar and Sherman Heights Community Center, plus Mass Creativity Project – 2015 by offsetting expenses for artists, marketing, art supplies, event and permit fees, an evaluation consultant, travel expenses for NCM, project documentation, and a short documentary film about the project; and

WHEREAS, the Children's Museum's request for funding for the Mass Creativity Project – 2015 will benefit those who – due to economic, cultural, or geographic constraints – may not make time to explore creativity or visit museums, may not make time to explore creativity or visit museums, and where tables of multi-generational family groups are joined by neighbors or local shopkeepers in participating in stimulating and nurturing the creative spirit through art-making workshops in safe and accessible venues led by artists and the Mass Creativity Project; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 8 recommends an allocation of \$12,000 to the Children's Museum for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and The New Children's Museum (Agreement) in an amount not to exceed \$12,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309720.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$12,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1108110008, to provide funds for the Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
