A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$1,000 TO THE FILIPINO-AMERICAN SENIOR CITIZENS ASSOCIATION OF SAN DIEGO FOR THE MIRA MESA SENIOR CENTER PEST CONTROL PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Filipino-American Senior Citizens Association of San Diego (FASCA) has requested funding for the Mira Mesa Senior Center (Center) Pest Control Program, as the group is responsible for building management and financial oversight of the Center; and

WHEREAS, the requested funding will be used to implement a one-year program of pest and rodent extermination, as well as take preventive measures to keep the pests and rodents from returning; and

WHEREAS, FASCA's request for funding for the Mira Mesa Senior Center Pest Control Program will benefit the low-income older residents and seniors who use the facility by providing a clean, safe, and healthy environment for those seniors to have lunch; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 6 recommends an allocation of \$1,000 to FASCA for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(b), which provides: "A request for funding and subsequent allocation may not be less than \$1500."

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 8, which provides: "Community Projects, Programs and Services funding should be considered a one-time resource, and planned uses should be one-time in nature, to avoid service interruptions or employee impacts if funding is discontinued."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Filipino-American Senior Citizens Association of San Diego (Agreement) in an amount not to exceed \$1,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309725.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1106110006, to provide funds for the Agreement, contingent

upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer. APPROVED: JAN I.
