DATE OF FINAL PASSAGE MAY 28 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO THE ADAMS AVENUE BUSINESS ASSOCIATION FOR THE HOLIDAY LIGHTS FOR KENSINGTON & KENSINGTON PORTION OF UNPLUGGED, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Adams Avenue Business Association has requested funding for the holiday lights for Kensington and Kensington portion of Adams Avenue Unplugged, a two-day acoustic music festival on Adams Avenue; and

WHEREAS, the requested funding will be used to purchase decorative lighting and holiday decorations to adorn the Kensington neighborhood sign, and to pay for staging, sound, and talent at the Kensington Library Park stage during Adams Avenue Unplugged; and

WHEREAS, the request for funding for the holiday lights for Kensington and Kensington portion of Unplugged will enhance marketing for local and foster community-building in Kensington, while Adams Avenue Unplugged will draw 20,000 visitors and consumers to Adams Avenue to enjoy free acoustic performances on the Kensington Library stage and in several of the restaurants; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 9 recommends an allocation of \$10,000 to the Adams Avenue Business Association for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Adams Avenue Business Association (Agreement) in an amount not to exceed \$10,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- **309727**.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1109110009, to provide funds for the Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


