A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$15,000 TO THE URBAN LEAGUE OF SAN DIEGO COUNTY FOR THE PATHWAYS RE-ENGAGEMENT & COMMUNITY ASSISTANCE SUPPORT TEAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Urban League of San Diego County (Urban League) has requested funding for the PATHWAYS Re-Engagement Team project and the Community Assistance Support Team; and

WHEREAS, the PATHWAYS program aligns with school district resources and workforce development investments to model innovative strategies that a growing number of cities have deployed to provide individual academic assessments, opportunities to explore different education options and referrals to appropriate schools or other credential programs; and

WHEREAS, the CAST is a mobile response team created in 2012 that has developed a comprehensive strategy to change the culture in neighborhoods plagued by violence with includes a gang intervention strategy and is lining easier accesses to services for individuals and families – and in their community – the capacity to change the present and create the future; and

WHEREAS, the requested funding will be for specific support of the programs as further detailed in the application for funding, attached as Exhibit A to the Agreement; and

WHEREAS, the Urban League's request for funding will benefit youth in the community by giving them the techniques, skills, and training participants need to help achieve excellence and could lead to an increase of economically and educationally self-sustaining citizens in the community using their consumer dollars in the community that supported towards their success; and

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06; and

WHEREAS, Council District 9 recommends an allocation of \$15,000 to the Urban League for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2015 City Council Allocations Agreement between the City of San Diego and the Urban League of San Diego County (Agreement) in an amount not to exceed \$15,000 for the projects described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 309735

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$15,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1109110009, to provide funds for the Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
