- 3. That the Chief Financial Officer is authorized to transfer appropriations, of \$720,000.00 from CIP S-12019, Scripps Ranch Pump Station to CIP S-11059, Otay WTP Plant Concrete Work within Fund 700010, Water Utility CIP Funding Source.
