A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE A THIRD AMENDMENT WITH RURAL/METRO CORPORATION FOR THE PROVISION OF EMERGENCY MEDICAL AND TRANSPORT SERVICES.

WHEREAS, the State of California Emergency Medical Services Authority (CalEMSA) is involved in a dispute over whether the City is able to issue an Emergency Medical Services (EMS) request for proposals; and

WHEREAS, CalEMSA recommend extending the City's current EMS Agreement with Rural/Metro Corporation as the City's current EMS Agreement is set to expire on June 30, 2015; and

WHEREAS, this extension will be done via a Third Amendment to the City's current EMS Agreement; and

WHEREAS, the term of this Third Amendment shall be five years, but the City has the option to terminate after the third or fourth year should CalEMSA allow the City to issue an EMS request for proposals at an earlier date; and

WHEREAS, the Third Amendment contains needed upgrades to the City's EMS system, including provisions for replacing aging ambulances, providing up-to-date equipment, and aligning the EMS response-time zones with the City's current population dynamics; and

WHEREAS, Rural/Metro Corp. has agreed to pay the City an annual EMS operations fee throughout the extended term of the EMS Agreement, the first fee equaling \$10,339,504 for FY 2016; and

WHEREAS, this fee will be received in Fund 20227, the Fire/EMS Transport Fund, and will go towards offsetting the City's cost of providing paramedic-level first response and administering the EMS system; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an amendment to the current Emergency Medical Services Agreement with Rural/Metro Corp., under the terms and conditions set forth in the amendment entitled "Third Amendment to 2011 Emergency Medical Services Agreement," on file with the City Clerk as document number RR 309758.
