A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO TO AUTHORIZE AN AGREEMENT
BETWEEN THE CITY OF SAN DIEGO AND THE
COUNTY OF SAN DIEGO FOR THE HEALTHY
WORKS PREVENTION INITIATIVE

WHEREAS, County of San Diego Health and Human Services Agency (HHS) is the local health department for the entire San Diego region, including the City of San Diego (City); and

WHEREAS, County of San Diego (County) is the recipient of a federal grant from the Centers for Disease Control and Prevention (CDC) to lead the implementation of its program, "Healthy Works: Public Actions to Prevent Obesity, Diabetes, Heart Disease and Stroke" (HWPFA), in partnership with the City and other local agencies (Federal Award Identification Number U58DP005528); and

WHEREAS, the HWPFA program is part of the County's long-term Live Well San Diego initiative to promote healthy, safe, and thriving communities, and reduce and prevent chronic disease through environmental, lifestyle and health systems changes as well as community-clinical linkage strategies within the City; and

WHEREAS, on December 10, 2013, the San Diego City Council approved Resolution R-308645 supporting the County's Live Well San Diego initiative; and

WHEREAS, under the proposed agreement, several City departments will provide services including: implementing nutrition and beverage standards at City worksites and for City vending machine contracts; working with Business Improvement Districts (BIDs) to strengthen

healthier food access and sales in retail stores and community venues; strengthening community promotion of physical activities; developing community active transportation plans to promote walking and biking; and implementing low or no-cost worksite wellness strategies and activities for City employees; and

WHEREAS, the City's activities will be funded on a cost-reimbursement basis through the County with the CDC grant funds of up to \$300,000 per year for up to four years, conditional upon renewal of the CDC funding each grant year; and

WHEREAS, the City and County desire to enter into the proposed Agreement to work together to implement the objectives of the HWPFA program and to continue to support the Live Well initiative; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor is hereby authorized and empowered to execute, for and on behalf of the City, the Agreement for Implementation of Healthy Works Program with the County of San Diego under substantially the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR309759, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement; and

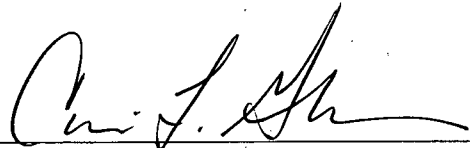
BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a fund for the Agreement, if necessary; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept grant funds totaling up to \$1,200,000 over four years (approximately \$300,000 for each program

year) on a reimbursement basis for the City's activities under the Agreement, and to appropriate and expend such funds; and

BE IT FURTHER RESOLVED, that the Mayor or his designee is hereby authorized to take all necessary actions to administer, monitor, and manage the Agreement for Implementation of Healthy Works Program, implement the program components as provided in the Agreement and when required, develop, advertise, negotiate and award contracts to third parties to implement the Agreement.
