WHEREAS, this action is for approval of a 4-year Agreement for Implementation of Healthy Works Program with the County of San Diego, and to accept and expend federal grant funds as a sub-recipient of up to \$1,200,000 awarded by the Centers for Disease Control and Prevention (CDC) to the County of San Diego (Federal Award Identification Number U58DP005528) for its Healthy Works Program. This program includes support to the City to produce active transportation plans and feasibility analysis for improvements; and

WHEREAS, the California State Legislature, through the California Environmental Quality Act (CEQA), Public Resources Code sections 21000-21177, has determined that CEQA does not apply to various types of projects listed therein; and

WHEREAS, CEQA section 21084 states that the CEQA Guidelines shall list those classes of projects which have been determined not to have a significant effect on the environment and which shall be exempt from CEQA; and

WHEREAS, pursuant to that authority, CEQA Guidelines sections 15260-15285 list the statutory exemptions promulgated by the California State Legislature; and

WHEREAS, the Council of the City of San Diego has considered the potential environmental effects of the Agreement for Implementation of Healthy Works Program, and

is statutorily exempt from CEQA pursuant to CEQA Guidelines section 15262.
