A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE AMENDED AND RESTATED 401(K) PLAN.

WHEREAS, the City of San Diego (City) established and maintains the City of San Diego 401(k) Plan (Plan), which was initially adopted by the City on July 1, 1985; and

WHEREAS, the Plan is a qualified governmental defined contribution plan under sections 401(a), 401(k), and 414(d) of the Internal Revenue Code; and

WHEREAS, the Plan must now be amended to conform to federal law applicable to qualified governmental plans, and to reflect the operation of the Plan; and

WHEREAS, the Plan must also be amended to conform to California law regarding registered domestic partners; and

WHEREAS, the Plan must also be amended to reflect that participants direct their own investments in the Plan, and that the Plan values accounts on a daily basis; and

WHEREAS, the Plan must also be amended retroactively, because it allowed participants to waive required minimum distributions for the 2009 calendar year, but did not amend the Plan to allow for this; and

WHEREAS, the San Diego City Council (Council) wishes to amend the Plan to allow employees to contribute flexible benefits credits from the City's cafeteria to the Plan; and

WHEREAS the Council also wishes to amend the Plan to accept eligible rollover contributions from other qualified retirement plans; and

WHEREAS, the Council also wishes to amend the Plan to follow the federal safe harbor

rules for hardship withdrawals, and the federal rules relating to qualified domestic relations

orders; and

WHEREAS, the Council also wishes to amend the Plan to allow the investment of funds

in group trust, such as the San Diego City Employees' Retirement System group trust; and

WHEREAS; the Council also wishes to amend the Plan to remove ambiguities and make

the Plan more intelligible for participants and City staff; and

WHEREAS, the proposed amendments have been provided to and discussed with all of

the City's recognized employee organizations, and none of these employee organizations have

raised any objections to adoption of the proposed Amendment and Restatement of the Plan; and

WHEREAS, it is now necessary to amend and restate the 401(k) Plan; NOW,

THEREFORE.

BE IT RESOLVED, that the Council of the City of San Diego approves the Amendment

and Restatement of the City of San Diego 401(k) Plan, which is on file in the Office of the City

Clerk as Document number RR- 30977
