DATE OF FINAL PASSAGE JUN 11 2015

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AN AMENDMENT TO THE COUNCIL POLICY 200-07 "MARKED CROSSWALK CRITERIA AT UNCONTROLLED LOCATIONS" TO INCORPORATE CHANGES IN PEDESTRIAN SAFETY PRACTICES AND TECHNOLOGY.

WHEREAS, pursuant to Council Policy 000-01, the City Council (Council) is charged with the responsibility of establishing municipal policies to guide the various functions of the City of San Diego (City); and

WHEREAS, Council Policy 200-07, "Marked Crosswalk Criteria at Uncontrolled Locations," provides standards for the installation of uncontrolled marked pedestrian crosswalks on City streets and specifies traffic control devices needed to enhance marked pedestrian crossing locations; and

WHEREAS, there have been substantial changes in pedestrian safety practices and technology since the current policy was adopted in 1990; and


WHEREAS, this Council Policy amendment incorporates those changes and replaces the existing Council Policy 200-07; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Council hereby adopts the revision to Council Policy 200-07 as set forth in Document No. RR- 309772 filed in the Office of the City Clerk.


2. The City Clerk is instructed to update the Council Policy Manual to include the revised Council Policy 200-07.
