A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AGREEMENT (H156306) WITH AECOM TECHNICAL SERVICES, INC. FOR THE PREPARATION OF A GROUNDWATER MANAGEMENT PLAN FOR THE SAN DIEGO FORMATION

WHEREAS, the San Diego Public Utilities Department requests approval of the San Diego City Council to award a consultant agreement for professional groundwater management services related to the research, development and preparation of a Groundwater Management Plan for the San Diego Formation as defined in the California Water Code, Sections 10750 through 10756 (Agreement); and

WHEREAS, the development of this Groundwater Management Plan is a term of a settlement agreement between the City of San Diego and the Sweetwater Authority authorized by the City Council on August 5, 2013, Ordinance O-20287; and

WHEREAS, AECOM Technical Service, Inc., was selected as the most qualified firm for the Agreement following the City's competitive selection and procurement process;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that

- 1. The Mayor, or his designee, is authorized to execute an Agreement with AECOM Technical Services, Inc. for the preparation of the San Diego Formation Groundwater Management Plan in an amount not to exceed \$949,974, for the duration of five years.
- 2. The Chief Financial Officer is authorized to expend an amount not to exceed \$949,974 from Water Utility Operating Fund 700011 for the purpose of funding the Agreement for Groundwater Management Plan consulting services, contingent upon adoption of the Annual

Appropriation Ordinance for the applicable fiscal year, and contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditures are, or will be on deposit with the City Treasurer.
