A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE REVISED SAN DIEGO PEDICAB PERMIT FEES AND AMENDING THE CITY OF SAN DIEGO RATEBOOK.

WHEREAS, the City of San Diego (City) currently charges a fee for Pedicab Decals and Pedicab Operating Permits; and

WHEREAS, the City's pedicab program is being transferred from the Transportation and Storm Water Department to the Police Department (Police Department); and

WHEREAS, pedicab owners and operators will be treated as a police regulated business; and

WHEREAS, the Police Department conducted a full evaluation of the costs and revenues associated with regulating pedicab owners and operators; and

WHEREAS, the revised pedicab fees comply with Proposition 26 as a reasonable regulatory cost exception and do not exceed reasonable costs of regulating pedicab owners and operators; and

WHEREAS, the revised pedicab fees include costs relating to issuing police permits, and investigation, inspection, administration, supervision, and enforcement; and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fees listed in the San Diego Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that a decrease in the Pedicab Decal fee from \$156.00 to \$122.00 is hereby approved.

BE IT FURTHER RESOLVED, that an increase in the Pedicab Operating Permit fee from \$91.00 to \$212.00 is hereby approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to include a Pedicab Decal Fee of \$122.00.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Ratebook to include a Pedicab Operating Permit fee of \$212.00.

BE IT FURTHER RESOLVED, that the revised Pedicab fees will be effective July 1, 2015.
